**INVITATION TO BID FOR
Procurement of Infra (Road Concreting of Rizal Street)**

The City Government of Tagbilaran, through the **20% Development Fund**, intends to apply the sum of **One Million Six Hundred Thousand Six Hundred Twenty One Pesos and 72/100 Only (PhP 1,600,621.72)** being the Approved Budget for the Contract (ABC) to payments under the contract for **ITB No. 1810-359**. Bids received in excess of the ABC shall be automatically rejected.

The City Government of Tagbilaran now invites bids for the **Road Concreting of Rizal Street. (Sta. 0+000.00 – Sta. 0+48.00), Tagbilaran City; B.5 Project Billboard/Signboard, B.7(1) Occupational Safety and Health, B.9 Mobilization/Demobilization, 102(3)a Surplus Rock Excavation, Soft, 103(1)b Surplus Excavation, Soft Rock, 104(2)a Embankment from borrow, common soil, 200(1) Aggregate Subbase Course, 311(1)c1 PCC Pavement (Unreinforced), 0.23 m thick, 14 days, 404(1)a Reinforcing Steel, Grade 40, 405(1)a3 Structural Concrete, Class A, 20.68 MPA, 28 days, 506(1) Stone Masonry, 600(1) Concrete Curb, cast in place, 600(3) Concrete Gutter, cast in place, 601(1) Sidewalk, 100 mm thk..** Completion of the Works is required within **24 Calendar Days**. Bidders should have completed, within TEN (10) years from the date of submission and receipt of bids, a single contract that is similar to the contract to be bid and must be at least fifty percent (50%) of the ABC of the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Local Government Unit of Tagbilaran City, Bohol and inspect the Bidding Documents at the address given below during office hours.

A complete set of Bidding Documents may be purchased by interested Bidders on **October 10, 2018 – November 6, 2018** from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Five Thousand Pesos (**PhP 5,000.00**).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the Procuring Entity's website: www.tagbilaran.gov.ph, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

The City Government of Tagbilaran will hold a **Pre-Bid Conference on October 18, 2018 at 2:00 PM** at **CEO Conference Room, CEO Building, Upper Calceta St., Cogon Dist., Tagbilaran City**, which shall be open to all interested bidders.

Bids must be delivered to the address below on or before **November 6, 2018 at 1:30 PM** at **CEO Conference Room, CEO Building, Upper Calceta St., Cogon Dist., Tagbilaran City, Bohol**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid Opening will be on November 6, 2018, 2:00 PM at **CEO Conference Room, CEO Building, Upper Calceta St., Cogon Dist., Tagbilaran City**. Bids will be opened in the presence of the bidders' representatives who choose to attend. Late bids shall not be accepted.

The City Government of Tagbilaran reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
