## INVITATION TO BID FOR Procurement of Goods [Multicab]

The City Government of Tagbilaran, through the **Appropriation Ordinance No. 17-18 for FY 2018**, intends to apply the sum of **One Million Eight Hundred Thousand Pesos only (Php1,800,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **ITB No. 1810-393**. Bids received in excess of the ABC shall be automatically rejected.

The City Government of Tagbilaran now invites bids **6 units MULTICAB – Specs: 4x2 FB type, Engine Mode: F6A 657cc 12-valve, Engine Power: 30 Horse Power, No. of Cylinder: 3, Transmission: 4 Speed / 1 Reverse, etc.** for the **CMO, Tagbilaran City**. Delivery of the Goods is required within **60 Calendar Days** after receipt of Notice to Proceed. Bidders must have completed, within 24 months from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section 11, Instruction to Bidders.

Bidding will be conducted through open competitive procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorship, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from the City Government of Tagbilaran at the address given below during 8:00 AM - 5:00 PM Monday to Friday only except holidays.

A complete set of Bidding Documents may be purchased by interested Bidders on **October 25 – November 20, 2018** from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **P5,000.00**

It may also be downloaded free of charge from the website of the Procuring Entity ([www.tagbilaran.gov.ph](http://www.tagbilaran.gov.ph)), provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

The City Government of Tagbilaran will hold a **Pre-Bid Conference** on **November 6, 2018, 2:00 P.M. at the City Engineering Conference Room, City Engineering Building, Upper Calceta St., Tagbilaran City**, which shall be open to all interested parties.

Bids must be delivered to the address below on or before **November 20, 2018 at 1:30 PM**. All bids must be accompanied by a bid security in any acceptable forms and in the amount stated in ITB Clause 18.

**Bid Opening** shall be on **November 20, 2018, 2:00 PM at the City Engineering Conference Room, City Engineering Building, Upper Calceta St., Tagbilaran City**. Bids will be opened in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.

The City Government of Tagbilaran reserves the right to accept or reject any bid, to annul the bidding process and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected suppliers.
